PROCESSING OF PERSONAL DATA

INFORMATIVE PURSUANT TO ART. 13 D. LGS. 196/2003 and ART 13 REG. EU 679/2016 pursuant to art. 13 of Legislative Decree No 196/2003 and of art 13 Reg UE 679/2016, we inform you of the following information: a) The data provided by you will be processed in order to carry out the **"GIOVANI IN CORTO NELLA TERRA DI PITAGORA FILM FESTIVAL"**, as well as for the Communication of future initiatives and the dispatch of informative and populative material; The data will be processed in paper and computer mode; B. The treatment in the subject is based on its consent. C. The conferral of the data, including the subscription of the disclaimer for the use of the short film, is mandatory for the improvement of the inscription; D) The refusal to provide the requested information entails the impossibility of perfecting the inscription and thus to participate in **"GIOVANI IN CORTO NELLA TERRA DI PITAGORA FILM FESTIVAL"**; e) The data will not be communicated to other persons without prejudice to the secretarial staff in charge of registration and preservation of data; The data will not be subject to diffusion, without prejudice to the possible publication of photographic and video material, including the short, on the institutional and social channels of the institution (in particular, sites, pages Facebook and Instagram, You tube, Vimeo and the like); f) At any time the person concerned may exercise the rights referred to in art. 7 D. Lgs. 196/2003 as well as the rights set out in the Artt. 15, 16, 17, 18, 19, 20, 21, 34 Reg UE 679/2016, contacting the data controller (legal representative, in person of the school manager of the I. C. "Pitagora" Bernalda Prof. Grazia Maria Marciuliano": I. In particular, the person concerned who relates the data may require confirmation or not of the existence of the same data and to know the contents, the origin, the purposes of the treatment and the Criteria used to determine the retention period of the same (right of access), verify their accuracy or ask for their integration, updating or correction (right of adjustment). The person concerned has the right to oppose, for legitimate reasons and at any time, the processing of the data (right of opposition). II. The person concerned has also the right to request the cancellation or blocking of the data processed in violation of the law, and to revoke at any time the consent to the processing of the data, without prejudice to the lawfulness of the treatment prior to revocation; The withdrawal of the consent and the request for the cancellation of the data results in the impossibility, for the controller, to proceed to the processing of the data (right to cancellation). III. The person concerned shall have the right to obtain from the holder of the treatment the limitation of the treatment when one of the assumptions provided for in the regulation, as well as the portability of the data provided. IV. The person concerned shall be entitled to be informed of any correction, cancellation or limitation of the processing of its data and to be informed in case of breach of personal data. V. The person concerned has the right to propose a complaint, if he suspected a breach of his rights, with the authority responsible for the protection of Personal data (www.garanteprivacy.it). g) The holder of the treatment is the Istituto Comprensivo" Pitagora "(60,
